

Terms and Conditions for Dash with Melissa Outlets 2019 Promotion

- These Terms and Conditions for the Dash with Melissa Outlets ("Promotion") are binding on all persons participating in the Promotion jointly organised by Telecom Equipment Pte Ltd ("Singtel") and [ENVIABLY ME PTE LTD] ("Merchant").
- 2. The Promotion shall be a period starting from 15st October 2019 and ending on 31st December 2019 (inclusive of both dates) ("**Promotion Period**").
- 3. Under the Promotion, and subject to these Terms and Conditions, eligible Dash Customers ("Eligible Customers") are entitled to \$10 off on a minimum purchase of \$100 worth of regular-priced items ("Special Discount") at any of the Merchant outlets in Singapore when making such purchase using their Singtel Dash Account to these terms and the Merchant's own terms & conditions.
- 4. To be eligible for the Promotion:
 - (a) Your Dash Balance must be and remain valid, and must not for any reason be terminated and/or suspended, during the Promotion Period; and
 - (b) You must comply at all times with the terms and conditions governing your use of Dash, including, but not limited to, the Dash Terms and Conditions and Terms and Conditions for Dash Visa Virtual Account (which may be accessed at http://www.dash.com.sg/terms).
- 5. Except for any cashback payable under the Dash First Use Cashback Promotion, this Promotion may not be combined by the Eligible Customer with any other on-going promotions and/or discounts loyalty programmes by Singtel unless otherwise stated by Singtel.
- 6. This Promotion is valid at only selected outlets at Melissa Wheelock Place, Melissa Raffles City and Melissa 313@Somerset for all regular priced items at these outlets.
- 7. Under this Promotion, all new users of Dash Payments will be entitled to a further discount of two dollars (\$2) provided that the new users pay for their regular priced purchases by Singtel QR Code.
- 8. Singtel or the Merchant reserves the right to terminate the Promotion in its entirety and/or to vary, amend, delete or supplement any of these Terms and Conditions, at any time, in its sole absolute discretion and without prior notice to you.
- 9. Notwithstanding any other provision of these Terms and Conditions, Singtel has the sole and absolute discretion to determine the eligibility of an Eligible Customer to enter and participate in this Promotion and your entitlement to the Cashback.
