

Terms and Conditions for Dash to Pizza Hut October 2019 Promotion

- 1. These Terms and Conditions for the Dash to Pizza Hut October 2019 Promotion ("**Promotion**") are binding on all persons participating in the Promotion jointly organised by Telecom Equipment Pte Ltd ("**Singtel**") and Pizza Hut Singapore Pte Ltd ("**Merchant**").
