

## Terms and Conditions for Dash RebateMango Promotion

- 1. These Terms and Conditions ("**Terms and Conditions**") for the Dash RebateMango Promotion ("**Promotion**") are binding on all persons participating in the Promotion jointly organised, conducted and operated by Telecom Equipment Pte Ltd ("**Singtel**") and RebateMango Pte Ltd ("**Merchant**").
- 2. The Promotion commences on 18 November 2018 and will end on 27 November 2018 (both dates inclusive) ("**Promotion Period**").
- 3. Under the Promotion, and subject to these Terms and Conditions, eligible Dash Customers ("Eligible Customers") shall be entitled to:
  - (a) a Merchant Credit of \$8 ("Merchant Credit") upon registering a new account with the Merchant ("RebateMango Account") via this link www.rebatemango.com/dash and successfully making a transaction through Dash via Dash Visa Virtual Account with any merchants on the RebateMango platform ("RebateMango Merchant"), during the Promotion Period:
  - (b) a 7% cashback ("Merchant Cashback") to the Eligible Customer's RebateMango Account, for every successful transaction during the Promotion Period ("Eligible Transaction"); and
  - (c) a 11% discount on all items purchased at the iHerb Inc's webstore (<u>sg.iherb.com</u>) ("**iHerb Discount**") during the Promotion Period.

To be eligible for the iHerb Discount, the Eligible Customer must access the iHerb Inc's webstore through the link <a href="www.rebatemango.com/dash">www.rebatemango.com/dash</a>, and the applicable Promo Code ("Promo Code") must be applied upon check out. Only 1 Promo Code may be applied for each Dash transaction. The Promo Code may not be applied jointly with any other promotional codes.
- 5. The Merchant Credit, Merchant Cashback and iHerb Discount are not exchangeable for cash.
- 6. RebateMango Merchants featured may be subject to change. The Merchant reserves the right to amend / append / withdraw terms and conditions without prior notice.
- 7. The Merchant Cashback is inclusive of all other cashbacks for the Eligible Transaction except for the Merchant Credit mentioned in Clause 3(a).
- 8. This Promotion may be combined with any other on-going promotions offered by Singtel. Unless otherwise stated, this Promotion is not valid with other offers, discounts, rebates, vouchers, privileges or promotions by the Merchant.
- 9. To be eligible for the Promotion:
  - (a) Payment for all purchases from RebateMango Merchants must be made through Dash via the Dash Visa Virtual Account.
  - (b) Your Dash Balance must be and remain valid, and must not for any reason be terminated and/or suspended, during the Promotion Period.
  - (c) You must comply at all times with the terms and conditions governing your use of Dash, including, but not limited to, the Dash Terms and Conditions (which may be accessed at <a href="http://www.dash.com.sg/terms">http://www.dash.com.sg/terms</a>).

The Merchant Credit and Merchant Cashback will be credited to your RebateMango Account by the Merchant, within 60 days of the qualifying transaction, in accordance with the Merchant's terms and conditions which can be found at <a href="https://www.rebatemango.sg/termsandconditions">https://www.rebatemango.sg/termsandconditions</a>.
- 11. Singtel reserves the right to terminate the Promotion in its entirety and/or to vary, amend, delete or supplement any of these Terms and Conditions, at any time, in its sole absolute discretion and without prior notice to you. In the event of such termination, Singtel may at its absolute discretion elect not to grant you the Merchant Credit, Merchant Cashback and/or iHerb Discount in respect of the terminated Promotion.
- 12. Notwithstanding any other provision of these Terms and Conditions, Singtel has the sole and absolute discretion to determine the eligibility of an Eligible Customer to enter and participate in this Promotion and your entitlement to the Merchant Credit, Merchant Cashback and/or iHerb Discount.
- 13. Singtel's decisions on all matters relating to or in connection with this Promotion and these Terms and Conditions shall be final. No correspondence or claims will be entertained.
- 14. Singtel is not an agent of the Merchant. Goods purchased from or through the Merchant ("Relevant Goods") shall be subject to such other terms and conditions as may be imposed by the Merchant and/or the respective suppliers or merchants for such goods, and you agree to be bound by such terms. In particular, orders that are exchanged, cancelled or refunded will not qualify for the Promotion.

Singtel makes no warranty or representation as to the quality, value, merchantability or fitness for purpose of the Relevant Goods and assumes no liability or responsibility for the acts or omissions of the merchants and/or suppliers of the Relevant Goods. Any dispute about the value, condition or performance of any of the Relevant Goods is to be resolved directly with the relevant merchants and/or suppliers of the Relevant Goods.

Singtel shall not in any event be liable in any way to you or any person for any loss, liability, damages or expense whatosever, howsoever arising, in connection with this Promotion (including, but not limited to, that arising from or in connection with any failure or delay by Merchant to credit or award the Merchant Credit, Merchant Cashback and/or iHerb Discount (or any part thereof) to you or any person).
