



## Terms and Conditions for Dash Shopee Promotion

1. These Terms and Conditions ("**Terms and Conditions**") for the Dash Shopee Promotion ("**Promotion**") are binding on all persons participating in the Promotion jointly organised, conducted and operated by Telecom Equipment Pte Ltd ("**Singtel**") and Shopee Singapore Pte Ltd ("**Shopee**").

6. The Terms of Service set out at <http://shopee.sg/legaldoc/terms> shall apply to all uses of the Promo Code ("**Shopee Terms of Service**"). Shopee reserves the right to amend Shopee Terms of Service or to cancel or reject use of the Promo Code at any time.
7. Only 1 Promo Code may be applied for each Dash transaction. The Promo Code may not be applied jointly with any other promotional codes.
8. This Promotion may be combined with any other on-going promotions offered by Singtel. Unless otherwise stated, this Promotion is not valid with other offers, discounts, rebates, vouchers, privileges or promotions by the Merchant.

Singtel reserves the right to terminate the Promotion in its entirety and/or to vary, amend, delete or supplement any of these Terms and Conditions, at any time, in its sole absolute discretion and without prior notice to you. In the event of such termination, Singtel may at its absolute discretion elect not to grant you the Discount in respect of the terminated Promotion.
13. Notwithstanding any other provision of these Terms and Conditions, Singtel has the sole and absolute discretion to determine the eligibility of an Eligible Customer to enter and participate in this Promotion and your entitlement to the Discount.
14. Singtel's decisions on all matters relating to or in connection with this Promotion and these Terms and Conditions shall be final. No correspondence or claims will be entertained.
15. Singtel is not an agent of Shopee. Goods purchased from or through Shopee ("**Relevant Goods**") shall be subject to such other terms and conditions as may be imposed by Shopee and/or the respective suppliers or merchants for such goods ("**Merchants**"), and you agree to be bound by such terms.

Singtel makes no warranty or representation as to the quality, value, merchantability or fitness for purpose of the Relevant Goods and assumes no liability or responsibility for the acts or omissions of the Merchants. Any dispute about the value, condition or performance of any of the Relevant Goods is to be resolved directly with the relevant Merchants.
17. Singtel shall not in any event be liable in any way to you or any person for any loss, liability, damages or expense whatsoever, howsoever arising, in connection with this Promotion.
